**SUGGESTION OF MOOTNESS**

Under Nevada law, ballot initiative proponents must submit sufficient signatures to counties for verification no later than the 15th day after the general election, which was November 20, 2024. *See* NRS 295.056(2); *see also* Nevada Secretary of State, *Filing a Statutory Initiative*, <https://www.nvsos.gov/sos/elections/initiatives-referenda/filing-a-statutory-initiative> (last visited Nov. 19, 2024) ("The last day for petitioners to submit signatures to counties for verification is November 20, 2024."). The undersigned is informed, including with information from the Secretary of State's office and Washoe County, and therefore believes that Respondents did not submit any

signatures to the counties by this deadline. Thus, this appeal is moot. *Personhood Nev. v. Bristol*, 126 Nev. 599, 602, 245 P.3d 572, 574 (2010) ("In this case, the appeal was rendered moot when appellants failed to submit sufficient signatures on the initiative petition by the June 15 submission deadline, rendering the proposed initiative ineligible for vote in the 2010 general election regardless of [this Court's] decision.").

Accordingly, this Court should dismiss this appeal as moot regardless of any suggestion that the proponents may propose a similar (or identical) initiative in the future. *Id.* at 603, 245 P.3d at 575-76.
